



Memorandum of Understanding
between
SEM NAN UNIVERSITY OF MEDICAL SCIENCES(Semnan-Iran)
and
GEORGIAN INTERNATIONAL ACADEMY OF SCIENCES(Tbilisi-Georgia)

Semnan University of Medical Sciences, hereafter referred to as **Semums** being a legal entity and acting according to the legislation of Iran, is legally represented under the charter by the **Rector Prof.Dr. Kamran Ghods**(hereafter – First Party).

and

Georgian International Academy of Sciences(ID:427727043), hereafter referred to as **GIAS**, being a legal entity and acting according to the legislation of Georgia, is legally represented under the charter by the **President Dr. Farzad Ghasemzadeh** (hereafter – Second Party).

Both of parties hereinafter separately referred to as the “Party”, collectively – the “Parties”, have decided to enter into the present memorandum of understanding (hereinafter referred to as the “MOU”) and agree with conditions as follows.

Article1. Purpose

The Parties believe that the quality of research and teaching is enhanced with the establishment of international cooperation, and wish to enter into collaboration with a goal of mutual enrichment in scientific, academic and cultural areas.

Article2. Areas of Cooperation

Within fields that are mutually acceptable, the Parties undertake to explore the opportunities for collaboration, which may include the following general forms of cooperation:

- 2.1. Establishment and run of the international campus of Semnan University of Medical Sciences in Georgia-Tbilisi.
- 2.2. Recruiting Bachelor, Master and PhD applicants to study at the international campus of Semnan University of Medical Sciences in Georgia-Tbilisi.
- 2.3. Holding joint higher education courses in the form of Dual, Joint and Collaborative Degree Programs in cooperation with foreign universities.
- 2.4. Developing international relations of the first party through:
 - 2.4.1. Signing scientific, research and educational memorandum with foreign universities.
 - 2.4.2. Holding international scientific conferences with the participation of foreign universities.
 - 2.4.3. Exchange of professors and students with foreign universities.
 - 2.4.4. Scientific journal production with the participation of foreign universities.
 - 2.4.5. Publishing joint articles with the participation of foreign universities.

Article3. Obligations of the Parties

- 3.1. The Parties intent to assist each other in the realization of the present MOU;
- 3.2. The Parties will exchange information and analytical materials essential for the most effective realization of the Parties Responsibilities identified in the given MOU;
- 3.3. Scheduled specific events will be carried out on the basis of additional contracts and agreements;
- 3.4. Detailed areas of cooperation, as well as exact conditions of cooperation in each area will be described in separate contracts.

Article4. Financial Terms of the MOU

Based on the type of cooperation in Article 2 of the MOU, separate agreements will be signed and financial condition will be mentioned separately there. **Parties have no financial commitment to this MOU.**

Article5. MOU Administrators

Ultimate responsibility for this MOU lies with the rector/president of each institution, but administrative responsibility for its administration will be delegated to the following officers at each institution.

- 5.1. For Semnan University of Medical Sciences: Head of International Affairs.
- 5.2. For Georgian International Academy of Sciences: International Relations Coordinator.

Article6. Validity of the MOU

- 6.1. This MOU comes into force when the authorized representatives of both Parties have signed it and is valid for 5 years.
- 6.2. Either Party may terminate MOU by giving the other Party a six-month prior written notice.
- 6.3. The MOU may be terminated upon written consent of the Parties as well.
- 6.4. When the MOU is terminated parties are obliged to fulfill their obligations towards all students and clients in the programs that already subscribed or signed contract before the ending of this MOU. They will cooperate under the conditions of this agreement to finalize all obligations.
- 6.5. The terms of the MOU can be amended only upon mutual consent of the Parties, addendums and amendments are valid only if they are made in writing and signed by the authorized representatives of the Parties.

Article7. Signatures of the Parties

The MOU is drawn and signed in seven articles, three pages and two equally copies in Persian and English, which all of them are equally authentic and shall come into force upon the signature at both parties.
